**COURSE PROVISIONS**

C & C Driving School will provide a minimum of 6 hours of classroom instruction provided by a certified instructor. *Classroom instruction shall not exceed 2 hours per day.*

**REQUIRED DEPARTMENT OF STATE INFORMATION**

Completion of driver education instruction does not guarantee qualification for a driver license.

**For a student to participate in segment 2, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a level 1 license, which has been held for not less than 3 continuous months.**

**CLASSROOM LOCATION**

Classes will be held at DeWitt Jr. High School, 2957 W. Herbison Road, DeWitt Michigan.

**TERMS**

The parent or guardian agrees to pay the amount of \$50.00 to C & C Driving School by or on the first day of class. All fees are due in full at the start of the program unless other arrangements are made. No Certificate of Completion will be issued until the student has paid in full.

Fees paid are for Segment II only. The cost of materials and supplies are included in the tuition. No additional fees for materials or supplies are required. As payment for tuition we accept cash, personal checks and money orders.

After successful completion of 6 hours of classroom instruction, the student will be issued a Segment II Certificate of Completion. Successful completion cannot be guaranteed. Students must pass the class to be eligible for a Certificate of Completion. **This course fee does not include Road Test fees.** Make-up time must be arranged with the instructor as needed. There is a written test included in Segment II class. Test must be passed with 70% accuracy and may be taken up to three times.

In case of a student's absence from class please call the phone number at the top of the contract. We ask that the student give a 24 hour notice if at all possible. Missed classes will be made up and arranged between the student/instructor/and owners of C & C Driving School. In the event of any type of emergency the parent/guardian will be immediately notified by phone.

### **CLASSROOM RULES**

Student hereby agrees to abide to the classroom rules addressed during the first day of class. Violation of these rules may be grounds for dismissal and forfeiture of any fees paid for the class.

### **REFUND POLICY**

If for any reason you decide to withdraw from the course before its completion, your refund will be based on the following: A full refund will only be issued before the start of class. If class cannot be completed the student would be allowed to enroll in the next class held. A partial refund of \$25 would be issued after the first day of class. No refunds after the first day of class.
